Auction Conditions:

1. Sale of material shall be **"As is where is basis"** & **"Ex-works"** from JSL, Hisar, Haryana plants in India.
2. Material belongs to JSL and no exclusive rights given to any party. All rights reserved to Jindal Stainless Limited, Hisar.
3. Sales Order/Invoice should be created with 100% Advance Payment Terms in SAP.
4. **Invoicing & Collection update:** The running payment for periodic lifting of the material by the customer shall be provided before placement of customer vehicle for lifting.
5. Company is fully authorized to use the material for its internal use or may provide the material to other vendor so as to make it usable for company, any time within/during tender period.
6. Auction Committee is authorized to change the tender period any time during the tender.
7. If the bid is accepted by the company and the bidder fails to follow the terms and does not start picking up the material within 3 working days from the date of deposit of Security amount, the company reserves the right to cancel the contract without any notice in this regard and also to forfeit the EMD or security amount.
8. **Customer Site Visit:** -The customer will have the right to inspect the material before auction on the basis of catalogue submitted to auction platform post depositing the EMD.
9. **Bid cancellation/postponement/Rejection:** Auction committee has the right to reject, postpone or cancel the bid without assigning any reason whatsoever.
10. **New Customer registration:** The customer who is participating for the first time in the tender must submit copy of GST registration certificate, Pan Card and cancelled cheque along with the tender form.

14. **SECURITY DEPOSIT:** The Sales order has been issued on receipt of security deposit which means the customer agreeing to all the terms and conditions which were disclosed at the time of auction. Which is 10% of total basic value. The Security deposit can be forfeited at any time upon failure of any terms and conditions.
15. **ISSUE OF SALES ORDER:** Issuance of Sales order is deemed that customer is agreeing to all terms and conditions.

EMD & Security Deposit: -

1. **EMD Amount:** Auction participants will have to deposit an interest free refundable Earnest Money amount of 2% (Full tender Value, Including GST value) of previous price of tender quantity into JSL bank account. Minimum EMD amount will be Rs. 5,000/-.
2. **Security Amount:** Security amount will be 10% (Full tender Value, Including GST value) of the auction's price and maximum quantity as per Tender Form. Successful bidder has to deposit interest free 'Security' within 0 working days after finalization of the bid/offer, failing which the earnest money will be forfeited. Minimum Security amount will be Rs. 10,000/-.

Penalty clause for irregular/Short Lifting: -

1. **Lifting by Customers:** Customer should lift the material as per the Sales Order. In case of lifting less than SO quantity, Auction facilitator should perform the below mentioned functions for the short lifting Qty./remaining Qty.
 - a. In case the H1 customers fails or slow lifting, then auction committee can authorize the plant-based facilitator to approach any customer to match the H1 price.
 - b. In case of new customer did not agree to provide H1 Price risk sell clause will be applicable.
 - c. Any unsold quantity of H1 will incur a penalty to the H1 customer on the basic price plus applicable taxes. This penalty will be recovered from the H1 Security amount.
 - d. H1 party have to adhere to the monthly lifting plan. Failing which penalty of 15% of the basic price (Taxation additional) will be charged on monthly remaining quantity.

For example, if the sale order specifies that the party must lift 10 MT of a product each month, but they only lift 8 MT in a month, the remaining 2 MT would incur a penalty based on the basic price of those 2 MT (Tax extra).
 - e. Auction Committee can also decide to include more customers to expedite lifting.
2. Further, the Company will not accept any claims for low stock quantities. If the actual stock exceeds Max Qty as per Tender form, then 5% positive tolerance will be allowed.
3. **Risk Sell Clause Applicable: -** If customer fails to lift the material with any reason & consequently company required to sell it to another customer with lower rate than the double of the differential loss amount will be recovered from the customer.

Security Forfeit Clause: -

1. Security Deposit forfeiture: In case of failure to comply with the SO terms, Auction committee can recommend forfeiture of the security deposit.

Clause for Pollution Certificate: -

1. The item for which the company has demanded the Pollution Certificate will have to be submitted to the company for verification three days before the auction. If it does not do so and an error is found in the Pollution Certificate, then the customer's EMD amount will be forfeited.

Safety Clause: -

1. Driver must Put on Safety-Helmet, Safety Shoes & Safety-Jacket in Plant premise (in the scope of customer).
2. Driving License (Heavy Vehicles), RC of Vehicle, Fitness certificate of Vehicle & PUC (Pollution under Certificate) required along with Driver.
3. Usage of Cell Phone is strictly Prohibited while driving
4. Sitting/Lying under vehicle is Prohibited

ROLE OF CUSTOMER

The role of the Customer is outlined below:

- The Customer would participate in the auction with the aim of bidding to secure the auctioned item in the Online Auction.
- The Customer would be provided access to the Online Auction through a "User ID" protected by a "Password". The Customer needs to ensure that the "User ID" and "Password" is not revealed to unauthorized persons. Customers are also requested to change the Password allocated to them by the "Service Provider" to keep their confidentiality. However it would be Customer's sole responsibility to ensure the security and privacy of the same and he/they would not hold the "Client" / "Service Provider" responsible in any manner whatsoever for any misuse of these user IDs and/or Password. The access to the auction mechanism shall be provided to all the approved Customers subsequent to obtaining their written consent to the General Rules & Regulations and the Letter of Interest. The payment of Pre Bid Deposit as decided by the Service Provider before the start of the Online Auction will be one of the necessary conditions for participating in the auction.
- Customers hereby confirm that they shall commit to lift the item (being bid for) at the price entered by them in the auction engine AND at the terms and conditions specified herein by the Client. All prices entered shall be legally binding on the Customers.
-
- Customers are strongly advised to exercise due diligence while placing bids. Failure to honor the bids placed during online bidding shall render the Customers liable for penal action as deemed fit by "Client" / "Service Provider".
- In the event of winning an allotment in the auction mechanism, the Customer shall commit to fulfill outlined obligations under the contract between Winning Customer and Client.

The Customers shall bid on the terms & place their bid in the auction engine in the manner specified herein. The Customers shall not stipulate any conditions on their own unless the terms herein expressly permit such conditions being stipulated by the Customer. Bids entered with conditions attached shall be considered Conditional bids & "Service Provider" retains the right of rejecting these bids even without intimating the Client.

• BIDDING RULES

The Bidding Rules refer to the information and terms defined specifically for a particular auction. The purpose of the Bidding rules is to provide approved customers with the information and terms specific to the auction in which they are bidding.

This would include:

- Definition of the unit bidding.
- Start Time and duration of the auction.
- Any extension of the duration of the auction in the event of bids being received towards the end of the pre-specified duration.
- Start Bid Price.
- Specified Unit for Bidding.
- Price Increments and any reduction in the price increment in the auction in the event of inactivity.
- Other attributes (informational/non-negotiable in nature).

While it shall be the endeavor of "Service Provider" to specify these rules at the earliest for each Online Auction. The "Service Provider" only in the case of unforeseen contingency beyond its control shall retain the right to delay the announcement of these Biddings rules or modify rules specified earlier at the time of the online bidding in prior written consent of the Client. These details would be available to the customers on the Auction Engine at the time of bidding.

The participation in the auction process presumes complete awareness and understanding of the bidding rules.

Only those Customers who have been approved by the "Client" and handed over stamped and manually signed "General Rules and Regulations governing conduct of Online Auction along with Letter of Interest, required EMD amount and other necessary documents to the "Service Provider" prior to the start of Online Auction will be given "Login ID" and "PASSWORD" to enable them view and participate in Online Auction. "JSL" will have the sole discretion to approve the Customers who have submitted bids and no requests will be entertained in this regard by Service Provider from the Customers.

The Online Auction shall be conducted on pre-specified date. The Key Terms pertaining to the conduct of Online Auction such as "START TIME", "DURATION", "END TIME" AND "AUTO EXTENSION FACILITY" Shall be specified separately for each Auction.

"Service Provider" retains the right to cancel or reschedule the Online Auction, with the prior written approval of the Client, on any of the following reasons:

- The number of confirmed Customers is deemed insufficient to conduct the Online Auction
- Some of the confirmed Customers are unable to access the module due to infrastructure problems such as sustained power failure or telecommunication breakdown.
- There are no bids, which are equal to or below Start Bid Price.
- Any other reason, which in the opinion of "Service Provider" / "Client" requires such action to be initiated.

The duration of Online Auction may also vary from the pre-specified period of time either on account of termination of the Online Auction by "Service Provider" on the advice of the Client.

OR

In case of situations where it is felt that continuance of the auction proceedings is prejudicial to the smooth conduct and / or the integrity of the auction process.

OR

due to Auto Extension during the Auction, duration may increase from specified period.

In the event of any problems being faced in the smooth conduct of the Online Auction, "Service Provider" with the approval of the Competent Authority of the Client, shall have the right to undertake one or more of the following steps:

- Cancellation/ premature termination of the Online Auction with/ without a subsequent rerun of the auction on a mutually decided date
- Cancellation of a bid
- Locking / deactivate a Customer's account (suspension of operations in the account), etc.

In case of failure of net connection, Customer will communicate his best price to the "Service Provider" and "Service Provider" will bid on behalf of the Customer with the minimum increment until the bid price reaches the best price offered by the Customer, by proxy bidding mechanism.

The best price communicated by the Customer will have to be authenticated by written confirmation or fax to the "Service Provider" and will be kept confidential between the "Service Provider" and the Customer. Customer will be bound by the price offered.

LIABILITY OF "SERVICE PROVIDER"

"Service Provider" shall not be liable to the Client/ Customers participating in the Online Auction or any other person(s) for:

1. Any breach of contract between winning Customer and Client.

2. Any delays in initiating the online auction or postponement / cancellation of the online auction proceedings due to any problem with the hardware / software / infrastructure facilities or any other shortcomings.

While, reasonable care and diligence will be taken by "Service Provider" in discharge of its responsibilities such as design of the online bid, communication of bid details and rules, guidance to client/ customers in accessing the Auction Engine and placing bids, etc. the customers shall specifically indemnify "Service Provider" from all liabilities for any shortcomings on these aspects. It is clearly understood that these activities are undertaken by "Service Provider" to assist the Customers in participation but the ultimate responsibility on all these counts lies totally with the customers.

RIGHT OF THE CLIENT:

The Client reserves the right to partially or totally accept or reject any / all bids placed in the Online Auction without assigning any reason whatsoever. The decision of the Client would be final and binding on the Service Provider and the Customer in any such case.

DEFINITION OF KEY TERMS

Auction

Auction refers to a forum where the requirement for one/more lots of an item is stated and the participants (customers) are required to bid down the price to be selected to supply the requirement.

Online Auctions

Online auctions refer to those auctions conducted through the Internet with the customers (from one or more

locations) simultaneously bidding to be selected for supplying the item/s on Auction. In other words, the venue for the auction is on an Internet website/ platform.

Services refer to the Online Auctions conducted by the Service Provider through its website as the venue for the purpose of the Online Auction and also includes the responsibilities narrated under the head "ROLE OF SERVICE PROVIDER" above.

Award at the Auction

In a single winner format, only one customer (normally the customer who quotes the highest price) is awarded all the units of the item being auctioned. The customer quoting the highest price is normally allotted the item.

Client

Client is the individual/business entity who has contracted "Service Provider" to conduct such auction. In case of auction, the purpose would be the genuine intent to sell the selected item/s (Lot) to the customers desiring to buy these items from the Client.

Customer

Customer is the individual/business entity participating in the auction, Intending to buy the item(s) from the Client. To become a Customer in the auction, a business entity has to secure client approval for participation and also provide written assent to the General Rules and Regulations.

Auction Engine

Auction Engine refers to the software that encapsulates the entire auction environment, processing logic and information flows. "Service Provider" is the sole owner of the auction engine and retains exclusive right over the utilization of the same.

Timings of the Online Bid

All the timings of the Online Bid shall be based on the time indicated by the Server hosting the Auction Engine. It shall be the endeavor of "Service Provider" to ensure that the Server Time reflects as closely as possible the Indian Standard Time (IST) i.e. GMT + 0530 hrs. However, in the event of any deviations between the Server Time and the Indian Standard Time, the functioning of the Auction Engine (Launch, operation, and closure) would be guided by the Server Time. Customers are advised to refresh both the windows of the Auction Module check the exact Server Time (displayed in both the windows).

Preview Time

Preview Time refers to the period of time that is provided prior to the commencement of bidding. This is to facilitate approved participants to view the auction details such as item specifications, bidding details and bidding rules. The purpose is also to familiarize participants with the functionality and screens of the auction mechanism. It is not mandatory for "Service Provider" to provide Preview Time.

Start Time.

Start time refers to the time of commencement of the conduct of the online auction. It signals the commencement of the Price Discovery process through competitive bidding.

Duration of the Auction.

It refers to the length of time the price discovery process is allowed to continue by accepting bids from competing customers. The duration of the auction would normally be for a pre-specified period of time. However, the bidding rules may state the conditions when the pre-specified duration may be curtailed/extended. The conditions include:

- Curtailment of auction duration in the event of no bids for a specified period of time (Inactivity Time)
- Extension of pre-defined duration of auction is the sole discretion of auction platform and JSL.
- Automatic extension in the event of bids being entered towards the end of the scheduled duration to facilitate the other customers to view and react to the bid.

Auto Extension of the Auction Timings.

In the event of bids in the last few minutes of the scheduled bid time, the Bid Timings are automatically extended for a specified period from each such bid. Such Auto Extension shall continue until no bids are placed for the specified period (Engine remains inactive for the specified period). The Inactivity Time for Auto Extension purpose is normally X minutes. "Service Provider" however retains the right to change the same. The Inactivity Time applicable for the particular Online Bid shall be visible to the customers under the Bidding Rules module on the engine.

Auto Extension of Bid:-

In the event of bids in the last 2 minutes of the scheduled bid time, the Bid Timings are automatically extended for a specified period from each such bid so that at least 3 minutes are there to each bidders to react & put their bid. However JSL retains the right to change the same.

End of the Auction.

End of the Auction refers to the termination of the auction proceedings signaling an end to the price discovery process.

Auction Report.

"Service Provider" would provide an Auction Report to the Client containing a summary of the auction proceedings and outcome. The Auction Report would constitute the official communication from "Service Provider" to the client about the outcome of the Auction.

Please Note: -

- All interested bidders are requested to inspect the items before the auction. It will be assumed that customers participating in the auction have inspected all the materials prior to the auction to the extent of their satisfaction.
- No complaints regarding the difference in material quality or quantity will be entertained once the auction is started.
- Materials sold would be under "as is where is" basis. Any Picking, sorting, cutting, cleaning or breaking up of scrap materials will not be permitted.
- Successful Bidders has to make his own arrangements for shifting, loading, unloading, weighing & transportation of scrap items at their own cost.
- Loading and weighing of the goods at designated weighing machine have to be executed in the presence of JSL authorized representatives. In case of any dispute, re-weighing shall be done on another weighing machine at the sole discretion of JSL.

- JSL will arrange to issue Tax invoice for the transaction without which the goods shall not be removed from the JSL warehouse.
- Any details like PAN, Bank A/c etc. and copies of documents require for creation of customer code in JSL system have to be provided by the successful bidder.
- Material Quantity is tentative & actual quantity may vary at the time of Lifting
- Applicable Taxes & Duties: The bids are to be placed in basic and exclusive of taxes and duties and any other charges. The winning Customer shall be liable to pay all taxes as would be applicable on the date of dispatch of the material and JSL would not be liable for taxes in any manner. 9.0 Arbitration
